CHILDREN IN PRE-K ATTEND A FULL SCHOOL DAY, FULL SCHOOL YEAR PROGRAM. CHILDREN PARTICIPATING IN THE PROGRAM MAY BE SERVED IN LICENSED PROGRAMS IN PUBLIC SCHOOLS, PRIVATE CHILD CARE FACILITIES, OR HEAD START PROGRAMS.
